

PRIVACY POLICY

Information about our Organisation and Website

Vitacress respects your privacy and is committed to protecting your personal information. We have adopted this Privacy Policy to explain what information may be collected on our Site and how such information may be used. This website is governed by the laws of Portugal. Portuguese courts shall have exclusive competence to take legal decisions relating to cases concerning the use of this website.

1. Information collected automatically

Our web server records the IP address of the visitor's Internet service provider automatically. This information identifies the computer used to access the site, and not its user. At no point do we access and analyse any personally identifiable facts in this process.
